#### **INSTALLATION**

Congratulations! You are new the owner of a Rosedale Products Model 8 sanitary filter unit. Our factory has taken great pains to package your unit so it will arrive safely at its destination.

- 1. Please remove all shipping and crating materials carefully. Be careful not to damage any of the projecting connections.
- 2. Position the filter into its proper location. Secure the legs to floor or platform.
- 3. Proceed with installation.




Figure 1. GENERAL LAYOUT

  - A. Connect inlet service line to inlet flange of filter vessel (see fig. 1).
  - B. Connect outlet service line to outlet flange of filter vessel (see fig. 1).
  - C. Remove cover ( to allow for filter basket and bag installation.)
  - D. Insert flange adapter into vessel. See fig. 1 for proper orientation of adapter. Adapter should seat securely in swaged portion of housing body shell.
  - E. Insert filter basket into vessel. Flange of filter basket should rest on lip of seal/flange adapter. (See fig. 1)
  - F. Insert filter bag into filter basket making sure filter bag ring is firmly seated inside of seal/flange adapter.
  - G. Replace cover and securely tighten the closure bolts or clamp to ensure a leak proof seal.
  - F. Ensure all connections are securely tightened. The unit is now ready for start-up.

## **OPERATION**

# FILTER SYSTEM START UP-PROCEDURE

- 1. Slowly open the inlet service line valve approximately 25% of normal operation flow.

  (Open claydy as not to displace filter has inside of hoveing)
  - (Open slowly as not to displace filter bag inside of housing).
- 2. After filter unit is pressurized, slowly open outlet service line valve until completely open.
- 3. Adjust inlet service line valve until desired flow rate is reached.

4. Observe the differential pressure and record the reading for future reference.

#### FILTER SYSTEM OPERATION

The filter requires a minimum amount of attention after the initial installation. Once the desired service flow has been established, the filter will operate efficiently until dirty. However, under no circumstances should more than 25 PSI differential pressure through the filter be obtained.

Operating the filter unit with high differential may cause filter bags to rupture or cause damage to filter system and downstream equipment.

To prevent excessive pressure drop through the filter unit, regular inspection of the filter media is required. Monitoring of differential pressure through the housing can be utilized as a means of determining whether or not the filter media needs cleaning or replacement.

#### FILTER SHUT DOWN AND FILTER MEDIA CLEANING/REPLACEMENT

- 1. Close the valve in the inlet service line to stop flow into the vessel.
- 2. Relieve the pressure from the filter unit.
- 3. Allow the vessel to drain through the outlet line.
- 4. Remove cover from housing.
- 5. Remove filter basket and filter bag. Clean filter basket thoroughly. Discard filter bag. (Cleaning and reusing the filter bag is not recommended.)
- 6. Remove debris and sludge from inside of inlet portion of vessel to avoid interference
  - with cover seal or flow of fluid being filtered.
- 7. Ensure the flange adapter is seated firmly in swaged portion of housing body. (See installation procedure for assistance.)
- 8. Install a clean filter basket and filter bag. (See installation procedure for assistance.)
- 8. Inspect cover gasket for cuts or other signs of failure and make sure it is properly seated.
- 9. Move cover back into position and attach the clamp top cover or the three bolt cover. With the three bolt cover alternately tighten the bolts evenly to ensure a leak proof seal between cover and housing body.

Your unit it now ready for operation. Refer to filter system start-up procedure.
